From a <u>CHECKING ACCOUNT</u> - a voided check, or a recent statement that states your Name, Routing # and Account #

From a <u>SAVINGS ACCOUNT</u> - a recent statement, stating your Name, Routing # and Account #

***<u>OR</u> a Bank/Credit Union ID Card stating your Name, Routing # and Account # for either Checking or Savings

Frequently Asked Questions

What is the Direct Debit service? Direct Debit allows the total amount of your tax bill to be automatically paid from your savings or checking account. When your sign up for the program, your property tax will be paid on the date you choose below.

What are the advantages of Direct Debit? Direct Debit offers you the convenience of making time-sensitive payments without having to write a check. Even if you are away, your tax bill will be automatically paid from your designated bank account.

How does it work? When you authorize Direct Debit, you are giving Thomas Township permission to initiate a transfer from your checking or savings account to the Township's account. The withdrawals are done by your financial institution and your monthly

bank statement will indicate the amount of the withdrawal and when it was made.

Will I still receive a tax bill? Yes, but for record-keeping purposes only. Tax bills are mailed on July 1st and December 1st of each year

or as close to those dates as possible. **What if my banking information changes?** Please notify the Township of a change in banking information by resubmitting this form with updated information, including the date the change is effective. Changes cannot be made over the phone or by email.

How do I cancel Direct Debit? Complete the Cancellation Request Form and return it at least ten (10) business days prior to the due date. Can I have my tax bill emailed to me? Tax bills are not permitted to be emailed per the Michigan General Property Tax Act, PA 206 of 193, MCL 211.44.
